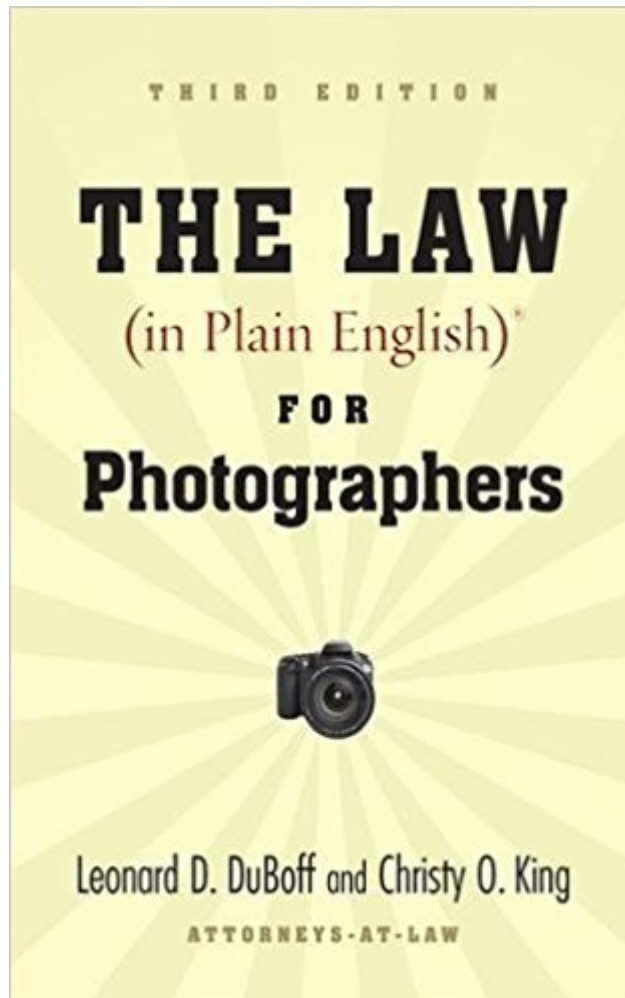

And other part of the book is just someone rambling. Each state is different so I recommend if you're really concerned with something you're wanting to do, ask a lawyer. Wait to think it said that in the book somewhere, well pretty much. It does have some necessary contract examples in the back of the book. But you can also find them online. Not a bad book but not the best. I will keep mine on the shelf as a quick reference.

Please be aware that if you order the Kindle version of this book, you'll get a similar book aimed at galleries and not for photographers. It would be nice if a Kindle version of this book were actually available.

If you are a lawyer like me, you may find this book interesting. I did.
