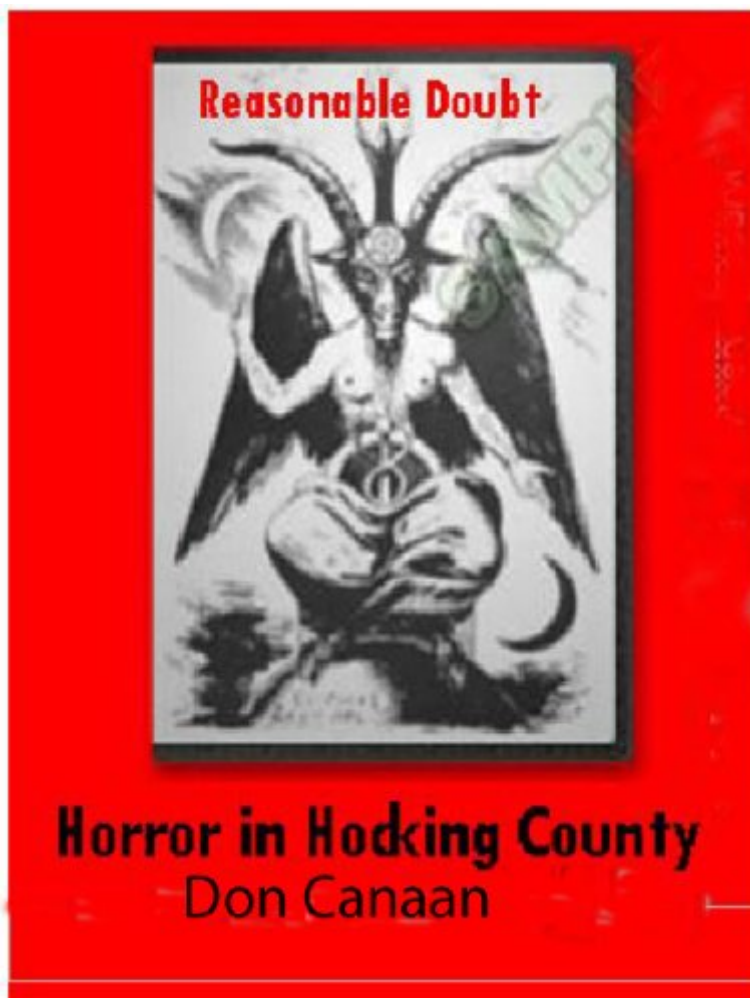

Reasonable Doubt: Horror In Hocking County



Synopsis

A Logan, Ohio resident, a father, accused of satanically murdering and dismembering his stepdaughter and her fiancée, and then scattering body parts in the Hocking River while burying other appendages in a nearby cornfield, was sentenced to die in the electric chair. "Horror in Hocking County" is a true crime account of parental hysteria and the aftermath in Logan. But Johnston's conviction by a three-judge panel was later reversed by the Ohio Court of Appeals. And that decision was subsequently upheld by Ohio's Supreme Court. Even though two other men later confessed to the gruesome crime, some Hocking County residents still believe in Johnston's guilt. This book examines the question of whether there was reasonable doubt?
